## White House Studies PRHI

PRHI Chair Karen Wolk Feinstein and Director Ken Segel had the honor of being called to the White House on Thursday May 3, 2001 to brief President Bush's chief health policy advisors on the strategy and work of the PRHI partnership. The White House is considering whether to make health care quality and performance improvement using system-based approaches a major initiative. The Administration's health policy leadership were assembled to review PRHI as an example of a community-driven project.

Among those present at the briefing were Cabinet Secretaries Tommy Thompson from the Department of Health and Human Services and Paul O'Neill from the Treasury Department; Karl Rove, Senior Advisor to the President; Tom Scully, nominated as Administrator of the Health Care Financing Administration; Mark McClellan, MD, PhD, Consultant to the President and Council of Economic Policy Advisor; Anne Phelps, Special Assistant to the President for Domestic Policy (Health); and Gregg Meyer, MD, Director of the Center for Quality Improvement and Patient Safety at the Agency for Healthcare Research and Quality.

Feinstein and Segel summarized PRHI's core principles and activities, and suggested ways that White House and Administration leadership could aid efforts such as ours:

- Re-focus the national health care debate on patient outcomes and "perfect patient care."
- Demonstration funding for community-wide outcome improvement efforts such as PRHI.
- Financial support for hospital systems seeking to install and use clinical outcomes tracking systems, possibly tied to restoration of funds taken from the Balanced Budget Act.
- Expanded support for HCFA demonstration efforts to reward good performance, including premiums for low-cost services that improve patient outcomes.

- Dedicated NIH funding and academic rewards for research and clinical involvement in outcomes improvement initiatives.
- Support for activity-based costing demonstration projects.
- Training and reimbursement for health professionals who provide leadership (coaching and problem-solving) at the point of care with skills in informed shared decision-making and process improvement. ☞

The mission of PRHI's Center for Shared Learning (CSL) is to support the testing and implementation of a system-based approach to healthcare management, drawn from the Toyota Production System (TPS) and Alcoa Business System.

PRHI partners are working collaboratively to eliminate two major patient safety concerns: healthcare-acquired infections and medication errors.

We continue to focus on two areas of work:

- (1) Holding information sessions throughout the region to discuss the application of TPS principles to health care; and
- (2) Supporting the learning lines at UPMC Presbyterian and South Side hospitals.

This month we were fortunate to welcome Dr. Steven Spear to the learning lines. Dr. Spear and his colleague from the Harvard Business School, Dr. H. Kent Bowen, co-wrote the article on the "DNA" of the Toyota System for the *Harvard Business Review*. (Call Tony Kelly for a copy.) Their knowledge of TPS and their support for the PRHI model have made them an integral part of the help chain at the Center for Shared Learning. They are also able to guide us as we apply the principles of TPS in a healthcare setting.

Dr. Spear and Dr. Bowen both plan to visit our learning lines again at the end of May.

### AHRQ Proposal

PRHI submitted a proposal to the Agency for Healthcare Research and Quality (AHRQ) for the grant: *Improving Patient Safety: Health Systems Reporting, Analysis, and Safety Improvement Research Demonstrations*. If approved, the research project, "The Implementation of a Regional Approach for Improving Patient Safety," will accelerate our joint efforts in preventing nosocomial infections and medication errors. The grant will fund staff to rotate through our partner hospitals, helping them to use the medication error and infection reporting systems.

Preparing the proposal enabled us to create a road map for: (1) expanding reporting system assessment; (2) learning how reporting can affect change; and (3) assessing the work environment in which the reporting is done.

PRHI is pleased to report that 30 of 31 eligible PRHI partnering hospitals submitted letters of commitment.

### Infection Control

Infection Control Practitioners at PRHI partnering facilities are collecting the data required for the PRHI bloodstream infection project. The initial month's data are scheduled for submission directly to the CDC by May 31, 2001, however, the CDC cannot accept this information before receiving authorized consent.

Consent forms and supporting documentation have just been distributed to the administration of participating hospitals. **The signed consent document should be returned directly to the CDC by May 18, 2001.**

Southwestern Pennsylvania seeks to achieve the best patient outcomes of any community in the world. PRHI has established a partnership among clinicians, businesses, hospitals and insurers to achieve those goals in five pilot areas by (1) constructing outcome data sets trusted by those who provide care and (2) supporting collaborative efforts to improve care.

### Cardiac Work Group

The Cardiac Report released last fall has led to powerful collaborative work among competing cardiothoracic surgeons, cardiologists, and hospital quality improvement officials. On the heels of a groundbreaking Work Group meeting, data analysts from several different institutions met to agree upon data definitions for a region wide Cardiac Registry. Clinicians selected risk-adjusted mortality and atrial fibrillation as preliminary improvement areas. The group is developing measures that will expand upon the PRHI report showing **how** each institution is faring. These new measures—a “data registry”—will add important details about **what** processes each system is using. Creating this “data registry” will allow physicians and hospitals to modify their work to get to better patient outcomes.

The group expects to complete its work in two more meetings, and hopes to begin collecting improvement data and sharing improved practices by the fall.

### Depression Report

In other news, the Clinical Advisory Committee expects to finalize the Depression Report in May and release it shortly thereafter. Preliminary reviews already show large variations in post-hospitalization follow-up and effective medication management. Attention also focuses on policy issues regarding the reinvigoration of partial hospitalization options.

### Diabetes Report

Finally, the Diabetes Work Group is coming together with the staffing of Susan Elster, who is contacting endocrinologists, primary care physicians, nephrologists, and pediatricians from several different systems to help frame questions for the final of the five first round reports.
